Mapping the Ali Kushayb Trial

Senior militia/Janjaweed leader (Ali Mohammed Ali Abd-Rahmen) accused of

31 counts of Crimes Against Humanity (Art 7) and War Crimes (Art 8) in Central Darfur from April 2003 to August 2004. Ali Kushayb (also spelled Ali Kosheib) voluntarily surrendered to the ICC on 9 June 2009 in Central African Republic.



July-August 2003

Mr. Harun (then State Minister for the Ministry of interior) gave a speech about the extermination of the Fur people.



15-16 August 2003

Militia/Janjaweed and GoS Forces allegedly killed 63+ persons from Kodoom, Bindisi and surrounding areas, including men, women, children and elderly persons. Under the instructions of Ali Kushayb they carried out systematic destruction of property belonging to predominantly Fur civilians in Kodoom and Bindisi.

Nomen & girls raped ? (no charges)



Between September 2003 and March 2004

Militia /Janjaweed and GoS Forces attacked several villages in areas surrounding Deleig causing thousands of civilians to seek shelter in Deleig, Garsila and other towns.



51 people killed



16 women & girls raped



July or early August 2003

Attack on 15th August, Ali Kushayb led an indiscriminate attack at Bindisi. With orders to move from Kodoom, Bindisi, Merly then to Bindisi Market in the North, then proceeded to the Southern part of town. 52 persons are said to have been killed and are listed in the confidential annexes (counts 1-11).



52 people killed



February-March 2004 - Mukjar

After the attack of the rebel forces on the Mukjar police station, Ali Kushayb directed an armed operation to attack Mukjar and surrounding areas. Janjaweed forces/GOS left from Garsila, passed through Mujra, and launched several attacks on surrounding villages including Tendy, Abirla, Arada, Dembow, Kabdy, Kirarow, Sigirgir and Nyerli (counts 12-21).



122+ men tortured, then executed

5-7 March 2004 Deleig: Executions

Attacks in Deleig (counts 22 to 31) targeting Fur male IDPs. 100s of males were rounded up tortured in an open area next to the Deleig police station. then transported to different locations and executed.

Between August 2003 and April 2004

Crimes against humanity especially against civilian members of the Fur tribe were committed, the attack further involved non-charged acts under article 7(1) which took place in Arawala, Forgo, Taringa, Andi, Fere, Seder, Gausir, Kaskeidi and Um Jameina localities.
